At the Drop-In Center, youth have access to basic need resources including hot meals, laundry and shower facilities, clothing, personal care/hygiene items, food, lockers, computers/internet access etc. Additionally, they are connected to a case manager who works individually with them to identify and connect them to other community resources while at the same time providing encouragement, advocacy, and support. Through the Drop-In Center youth can also utilize housing navigation program services like the Hope Homes program that stabilizes "couch-hopping" youth by providing financial stipends and support to youth and adult hosts willing to be a stable, dependable relationship for the youth while also providing them
